Mayor Mance called the meeting to order.

3. Canvassing Board will count the Ballots:

Micanopy Election Polls closed at 7:00 PM.

The Town Commission acts as the Canvassing Board.

The manual count of the absentee ballots followed this procedure: The ballots were separated into 4 stacks and each canvassing board member observed the ballots, marked their tally sheet, and reported the total votes for each candidate. Commissioner Parker erroneously counted 19 votes for Roberts, but recounted the votes, and corrected his total to 18 for a total of 27 absentee ballots. Tally for absentee ballots are as follows:

The canvassing board confirmed and certified the ballot box votes provided by Poll Worker, Clerk Mathers

Ballot Box #1 (Total 40 votes)	20	20
Ballot Box #2 (Total 189 votes)	<u>88</u>	<u>101</u>
Total Ballot Box Votes	108	121

We have two tallies from the voting machines: Ballot Box #1 had 40 votes cast and Ballot Box #2 had 189 votes cast for a total of 229 votes on machines, plus 27 votes from absentee ballots = 256 total votes for this election.

Votes cast for Seat #5:

Incumbent Candidate Roberts = 139 votes

Candidate Layla Ruffino = 117 votes
