Service Rates as of August 1, 2019

Water Rates:

Base Rate = \$20.07 + \$2.19 from 0 – 1,000 gallons used = \$22.26 minimum rate per month.
 The cost of each additional 1,000 gallons (or part thereof) is scaled from \$2.46 to a maximum of \$6.56 per 1,000 (or part thereof) as flat rate for usage over 10,000 gallons (see rate schedule for 1,000 gallon rate increments.)

Residential Garbage Rates per month:

Once-weekly pick-up
 Curbside = \$19.19

Commercial Garbage Rates per month:

Once-weekly pick-up
 Curbside = \$32.00
 2-yard Container = \$79.59
 4-yard Container = \$159.17
 6-yard Container = \$238.76
 8-yard Container = \$318.34

Water Deposit: \$75.00 (refundable less any outstanding charges when account is closed)

Turn-on/Account set-up Fee: \$25.00

New Water Meter Installation: \$750.00

Bills are mailed monthly after meters are read and payment is due upon receipt. If payment is not received by the 21st of the month following the billing date, a 10% service charge will be added to the account.

The water meter is the property of the Micanopy Water Utility Department. Full access to the meter must be maintained at all times. Meters should not be fenced, locked, tampered with, or turned on/off at any time, and the customer is legally liable for such action. If dog(s) are within the proximity of the meter, the meter may not be read.

A copy of the Micanopy Code of Ordinances (Ordinance 2016-09), Chapter 35, Article III Micanopy Water Utility, and Resolution 2019-12 Town Fees providing for discontinuance of service due to non payment and specifying penalties, and other such related information and regulations may be obtained from Town Hall upon request.
